$$u_{tt} - u_{xx} = 0$$

$$u(x,0) = \begin{cases} \sin \pi x & \text{if } 0 < x < 1 \\ 0 & \text{otherwise} \end{cases}, \qquad u_t(x,0) = \begin{cases} \pi \cos \pi (x-2) & \text{if } 2 < x < 3 \\ 0 & \text{otherwise} \end{cases}.$$

Find and draw the solutions at t = 1, 2, 3 if

(1).
$$x \in (-\infty, \infty)$$
.

(2). $x \in (0, \infty)$ with $u_x(0, t) = 0$.

For both (1) and (2)

- (3). Find and draw the domain of dependence of the point (x, t) = (1, 2).
- (4). Find and draw the range of influence of the point (x, t) = (1, 0) up to t = 3.

A2. Solve Laplace equation

$$\Delta u=0,\quad \Omega:\{x\in(0,1),y\in(0,1)\}$$

with the boundary condition

$$u(x,0) = 0, \quad u(x,1) = 4x(1-x)$$

 $u(0,y) = \sin 2\pi y, \quad u(1,y) = \sin \pi y.$

Find the maximum and minimum of the solution.

A3. For the conservation law

$$u_t + f(u)_x = 0$$

where flux function is f(u) = u(1+u).

$$u(x,0) = \begin{cases} u_l & x < -1 \\ u_m & -1 < x < 1 \\ u_r & x > 1 \end{cases}$$

- (a). Draw characteristics and find solution u(x,t) if $u_l = u_m = 1$ and $u_r = 3$.
- (b). Draw characteristics and find solution u(x,t) if $u_l = 3$ and $u_r = u_m = 1$.
- (c). Draw characteristics and find solution u(x,t) if $u_l = 3$, $u_m = 2$ and $u_r = 1$.
- (d). Solve the Riemann problem

$$u(x,0) = \begin{cases} u_l & x < 0\\ u_r & x > 0 \end{cases}$$

(e). Find the Riemann solution at x/t = 0.

A4. Prove for any $\alpha \in \mathbb{C}$ and $n \ge 2$ that the polynomial $\alpha z^n + z + 1$ has at least one root in the disc $\{|z| \le 2\}$.

A5. Compute

$$I = \int_0^\pi \frac{1}{2 - \cos x} dx.$$

B6. Consider the function $f : \mathbb{R}^2 \to \mathbb{R}$ defined by

$$f(\boldsymbol{x}) = \frac{1}{2}(x_1^2 - x_2)^2 + \frac{1}{2}(1 - x_1)^2.$$

- a) Use the first- and second-order optimality conditions to show that $x^* = [1, 1]$ is a local minimum.
- b) Give the linear system for the first iteration of Newton's method for minimizing f using $x_0 = [2, 2]^T$ as the starting point.
- c) Give the first iteration of the steepest descent method for minimizing f using $x_0 = [2, 2]^T$ as the starting point.

B7. For an initial value problem

$$y'(t) = f(t, y),$$

with $y(0) = y_0$, Heun's method given by

$$y_{k+1} = y_k + \frac{h}{2}(k_1 + k_2),$$

where

$$k_1 = f(t_k, y_k) k_2 = f(t_k + h_k, y_k + h_k k_1).$$

a) Write the Butcher array of this method in the form of $\frac{c \mid A}{\mid b^T}$. Recall that the general form of an *s*-stage Runge-Kutta method can be given as

$$u_{k+1} = u_k + hF(t_n, u_n, h; f), \quad n \ge 0,$$

where

$$F(t_n, u_n, h; f) = \sum_{i=1}^{s} b_i K_i,$$

$$K_i = f(t_n + c_i h, u_n + h \sum_{j=1}^{s} a_{ij} K_j), \quad i = 1, 2, \dots, s$$

- b) Show that this method is second-order accurate.
- c) Consider the special case $f(t, y) = \lambda y$ with $\lambda \in \mathbb{R}^-$. Find the maximum h such that the method is stable.
- d) How does Heun's method compare against the trapezoid method in terms of stability and stability?

B8. Consider the boundary value problem

$$-u''(x) + b(x)u(x) = f(x), \ 0 \le x \le 1$$

$$u(0) = u_l, \qquad u(1) = u_r$$
(1)

where b(x), f(x) are continuously differentiable, and $b(x) \ge 0$.

- a) Formulate a second-order difference method for finding the approximate solution of (??) on a uniform mesh of size *h*.
- b) Suppose b(x) = 0 and $u_l = u_r = 0$ in (a). Formulate a finite element method for finding the approximate solution of (??) in this special case, also on a uniform mesh. Using the standard "hat functions" basis for the finite element space, write out the equations for the Galerkin method.

- (a) Describe two versions of the Godunov method for hyperbolic conservation laws and comment on which one has implementation advantages.
- (b) Solve the Riemann problem for a linear system of strictly hyperbolic PDE's

$$U_t + AU_x = 0, \quad U(x,0) = \begin{cases} U_l, & x < 0 \\ U_r, & x > 0 \end{cases}$$

(i.e., express the Riemann problem solution in terms of eigenvalues, eigenvectors, and the jump $[U] = U_r - U_l$).

(c) Using the Riemann problem solution, derive the Godunov method for this linear system and show that it is equivalent to the upwind method.

- (a) Derive an ADI scheme for the 2D parabolic equation $v_t = \nu(v_{xx} + v_{yy})$ by performing an incomplete factorization of the BTCS scheme.
- (b) Discuss its consistency and perform stability analysis using the discrete Fourier transform.
- (c) Discuss advantages and disadvantages of your scheme compared to the BTCS scheme and the Pieceman-Rachford ADI scheme.
