The step by step instructions assumes that you have already submitted a FAFSA and is meant to help you update your FAFSA using the online IRS Data Retrieval Tool.

Step 1: Go to <u>www.fafsa.gov</u> and click "Login".



Step 2: Enter your FSA Username and Password and click "Next".
