

2021 LEGISLATIVE SESSION WRAP-UP

The 2021 New York State Legislative Session officially came to a close in the early morning hours of June 11, 2021. However, with several outstanding legislative initiatives requiring action by the state Senate and Assembly, both houses have indicated they are likely to return to Albany in the coming weeks/months to take up additional bill passage.

In the post-budget phase of this session, SUNY advocated for 11 non-budgetary pieces of legislation. These include bills that are important systemwide, but also bills specific to campuses. Our work included collaborative advocacy efforts with CICU, CUNY, UPD, union partners, local community leaders, and many others.

Of these 11 bills, 7 passed both houses, 2 passed the Senate and await Assembly action, and 2 require action in both houses. Additionally, SUNY opposed 2 bills deemed detrimental to the system – neither of which passed both houses. One final bill, concerning athlete compensation, required significant staff time to ensure language that would not cause harm to our campuses. Ultimately, revisions adopted were not enough to earn SUNY's support and the bill only passed the Senate.

Though Session is complete, the likelihood of the Legislature's return later this summer means that our advocacy will continue in securing support and passage of the remaining bills.
