Purpose:

This introductory course is designed to provide an overview of modern Nuclear and Particle physics. There are many textbooks, but they mostly cover basic 20-th century material. I expect to include more recent discoveries, e.g. of quark-gluon plasma and merging neutron stars on nuclear side, and Higgs discovery at LHC. Therefore I will provide lecture files as we go, with information collected from multiple sources.

Approximate content:

(*) Discovery of nuclei: the Rutherford experiment

- (*) Tunneling, very long-living isotopes
- (*) The map of the nuclear world
- (*) Nuclear forces, Yukawa potential, deuteron and He^4
- (*) The shell model
- (*) Cosmological nucleosynthesis
- (*) Processes in the stars
- (*) The nuclear fusion program, reactors and energy generation
- (*) neutron stars, their life and merger: heavy isotopes
- (*) accelerators and detectors, elements of relativistic kinematics
- (*) Quantum chromodynamics, quark types

(*) nonrelativistic hadrons: heavy quarkonia

(*) mesons and baryons in quark models. The 4 and 5-quark states

(*) QCD symmetries broken in the vacuum, the condensates and the pions

(*) heavy ion collisions and discovery of quark-gluon plasma

(*) Standard model of electroweak interactions, breaking of parity P and C with CP conserved

(*) gauge bosons, leptons and neutrinos

(*) CP violation: mass matrix for quarks and leptons

(*) cosmological puzzles: dark matter and cosmological constant

What to Expect:

This course will require you to carry out homework assignments weekly: as usual, doing these problems reinforce the material presented at the lectures. This course will not involve a lot of mathematics new to you, although for deuterons and quarkonia we will need to solve quantum Schrödinger equation numerically and do multiple plots of the results.

Preparation for future HWs I will advocate usage of Mathematica not only in few occasions when it will be necessary, but everywhere. Yes, it will require some learning curve but will save you a lot of time! Please upload free version from University web and learn elementary tasks like plotting a formula, or substituting "data" into an expression. (Note that one should put in the numerical values WITH their units, which will let you know what units the result will have.)
