## I. General Information

On behalf of the Curriculum Committee, I am pleased to submit our annual report for the last academic year, 2014-2015. This report was discussed and approved by the Committee on December 2, 2015.

- The report includes excerpts from the meeting minutes that discuss issues submitted to the Committee. As Secretary of the Curriculum Committee in AY 2014-2015, I would be happy to meet with the Executive Committee and/or the Senate to discuss the Committee's concerns.
- The curriculum committee met 19 times during the 2014-2015 academic year (one of those 19 times was a meeting of the Stony Brook course certification committee). Committee members were: Arlene Feldman (Academic and Transfer Advising Services, ex officio member), Kane Gillespie (College of Arts and Sciences, Executive Secretary of the committee, ex officio member), Daniel Gross (Registrar's Office, ex officio member), Dawn Harris (Africana Studies), Tim Hyde (Philosophy, Chair of the committee for Spring 2015), Roy Lacey (Chemistry), Sarah Malmquist (Neurobiology), Marie Huffman (Linguistics, joined committee Spring 2015), Greg Ruf (Cultural Analysis and Theory), Beth Squire (College of Arts and Science Dean's Office, elected professional staff member), and Peter Stephens for the Fall 2014 semester (College of Arts and Sciences, ex officio member, Chair of the committee for Fall 2014). Ridha Kamoua attended as his scheduled permitted as an ex-officio representative from the College of Engineering and Applied Sciences.
- Routine matters are handled by the secretary and announced to the committee at each meeting. There were a number of routine matters chiefly involving deletion of courses, reactivation of courses deactivated within the past five years, minor changes to major and minor Bulletin text, and changes of course titles, descriptions, course combinations and/or prerequisites to bring them in line with current teaching practices.
- The Committee worked to publish two updated online versions of the 2015 Bulletin (Spring 2015 and Fall 2015 editions). The secretary also serves as the Editor of the Bulletin, and elected professional CAS Dean's Office staff member Beth Squire serves as Assistant Editor of the Bulletin.

## II. General Curricular Matters

The committee approved 58 new courses during the 2014-2015 AY.

The committee met one time during the 2014-2015 AY as part of the larger Stony Brook Curriculum Course Certification Committee (with agenda items for a second meeting approved electronically). The SBCCC is made up of all of the membership of the Curriculum Committee, along with members representing other academic and non-academic areas on campus. The SBCCC voted on and approved courses pre-approved by the Arts and Sciences Senate Curriculum Committee, and the College of Engineering and Applied Sciences Curriculum Committee. The SBCCC also reviewed proposals from Health Sciences degree programs.

Many departments chose to add 0-credit courses that satisfy SBC learning outcomes SPK and WRTD (course number 458 satisfies SPK and 459 satisfies WRTD). These 0-credit courses were created to be taken in conjunction with a credit-bearing course, so that while not all enrolled students may satisfy the learning outcome, students who go beyond the minimum requirements for the class are able to earn the appropriate learning outcome. These courses were added as routine items for the curriculum committee.

The committee approved the addition to LANG to select 200- and 300-level foreign language courses to reduce the number of student petitions for LANG, and approved the proposed Online Chemistry Placement and Preparation process.

The committee approved the proposed BS/MS programs in Marine Vertebrate Biology and Atmospheric and Oceanic Sciences, and the proposed BA/MA for the Environmental Studies/Marine Conservation and Policy program.

The majority of the committee meeting time was devoted to reviewing course proposals and syllabi for existing courses to determine applicability to the Stony Brook Curriculum learning outcomes, along with proposals for new courses. The committee also spent a great deal of time reviewing syllabuses for existing courses proposed as online courses, in many cases referring the faculty to the Faculty Center for a more in-depth review of the syllabus.

The committee discussed several strategies to improve student success and reduce demand on upper division BIO and PSY courses. The curriculum committee encourages:

(a) Stronger advising for students as they enter and progress in the BIO or PSY major, using EAB software or course history. We can discourage students with weak indicators for success in the BIO or PSY major but the members were not in favor of us rejecting students outright.

(b) Possibly developing a set of criteria to flag students who are not doing well and who could be required to drop the major (in the context of improving student success).

(c) Meeting with the chairs of BIO and PSY, among others. They also pointed out that we should extend our conversation for BIO to bio-like majors, such as biochemistry, marine biology, health science majors, etc. If there were to be a proposal to restrict these majors, the proposal should come from the chairs of the departments, supported by justification that the restriction would improve student success.
