

Arts & Sciences Senate Meeting Minutes March 8, 2021 3:30PM - 5:00PM Virtual Meeting

- 1. Called to Order 3:30PM.
- 2. Acceptance of the <u>Agenda</u>: The motion to accept the agenda is carried.
- Approval of February 8th Meeting <u>Minutes</u>: The approval of the February 8, 2021 minutes is carried.

4. President's Updates:

- Meeting with Deans in EC meeting to discuss returning to the traditional casting reports in each meeting.

In the Library we lost access to SciFinder last week, but a couple of days later got back the access. We will make sure that this won't happen again and get done timely in future.
