2. Updates

- a. SHS
 - i. Flu Pods at Rec Center underway in month of October
 - 1. Flu pods from 5-8pm and 12-2pm, partnering with Rec; students can walk in and they are free
 - 2. Flu vaccines are available at SHS
 - 3. CPO also arranging a series of CVS Flu pods
 - ii. Flu vaccines available at SHS
 - 1. Can call for appointment or walk in
 - iii. Due to high volumes of students, some students are reporting difficulty getting an appointment; however if they schedule and make an appointment they should be able to get one within a day or so

- iv. If possible use Timely Care for after hours or if it can be a virtual appointment
- b. CAPS
 - i. Groups started (Grief, LGBTQ, SA women, DBT informed, Latin Students)1. Available to all students
 - ii. 23% increase in CAPS student seeking services
 - 1. Students want to be seen in person, there 60 appointments a week for new appointments
 - 2. If students want to be seen virtually please use Timely Care, must be 18 or older and if younger than 18 they must get parental consent and same goes for CAPS as well; some exceptions
 - iii. Role of case management
 - 1. The team can connect students to the providers that they need ie long term therapy, psychiatry, etc. ; they coordinate these services for students using their insurance
 - 2. Case managers take care of walk in students, especially if the student in crisis
 - 3. Case managers can also link students to Krasner Psychological Center
- c. CPO
 - i. Student led recovery group called Sober Brook, it is student led and being in recovery is not required, Thursday at 4pm in CPO office for anyone in recovery, sober, sobercurious, wanting to support, etc.
 - ii. Planned Parenthood Bus coming to campus 10/18!
