Note that these statistic were not posted prior to 2019. The incentive for being more transparent was because of a confluence of events, including COVID, which caused a spike in cases; a new, inexperienced associate provost, who overturned an unprecedented number of cases as the result of perceived legal pressures due to a spike of cases in which students hired lawyers. As a consequence there was an unprecedented number of lawyer-associated cases whose appeals were granted, an uproar amongst faculty and hearing members etc. who felt slighted The good news is that the integrity office now has a streamlined system of data collection that allows statistics to be posted on the web page , which bolsters transparency

2. Policy updates

a. NO ATTORNEYS In accordance with other SUNY academic integrity policy, we have stipulated no attorneys may attend hearing as witnesses.UPDATED ONLINE

"A student accused of violating academic integrity will be given an opportunity to address the hearing board. The student may bring an advisor or witness. In no such case shall the advisor be an attorney. An advisor may not speak on behalf of a student nor do they have privilege of the floor. The Academic Judiciary Office must be notified of the intention to bring advisors or witnesses no later than two working days prior to the hearing.

b. Multiple levels of student appeals- Consider changing? One issue that is different @ SBU vs other SUNY is level at which students can appeal post hearing. We have "1st appeal to Associate Provost, but if denied, a 2nd appeal to Vice Provost Vice Provost ?????

a. Put in writing Q course policy course should align with I in terms of time frame (students must complete Q course with in 1 year).
