Summary of Discussions and Actions

- 2024-25 was a rebuilding year for SCEDIT, its first year as a standing committee. Membership is largely new this year, and new co-chairs were elected. Previous chairs remain on the committee as non-voting members, and the bylaws were amended to allow the past chairs to remain on the committee during a transitional period.
- Subcommittees on AI Advisory and AJC Technology Advisory were established.
- Concerns over the introduction of AI tools that impact pedagogy without consultation of faculty (NotebookLM) have been addressed with the CIO. We asked him to consult with SCEDIT before publicly endorsing an AI program that impacts pedagogy, like NotebookLM does.
- SCEDIT investigated faculty complaints over the Student Accessibility Support Center's use of GLEAN note-taking software. The issues were related to a lapse in communicating these guidelines and the introduction of AI into an existing tool. The

faculty were not made aware of their right to ask students to turn off recording software during sensitive discussions. The executive director, Wendi Mathews, met with SCEDIT in April to discuss strategies for better communicating guidelines related to its use. This conversation and a demo of Glean were shared with SCEDIT members. If members have further questions, Wendi will attend a SCEDIT meeting. However, SCEDIT members seemed satisfied with learning more about it and the actions to be taken.

- SCEDIT is working with DoIT to establish a formal procedure for evaluating new software purchases for pedagogical impact (impact on learning objectives, student experience, faculty effectiveness).
- SCEDIT discussed problems encountered by IT and CELT with oversight regarding programs currently used on campus that newly introduce AI.
- Victoria Pilato represents SCEDIT in the Digital Governance Framework committee led by CIO Simeon Ananou.
- The committee is being updated on the upcoming legal changes in NYS to accessibility (which includes all faculty PDFs and course content). Rose Tirotta-Esposito has been leading on this and informing the committee of upcoming deadlines (the current deadline is April 2026).

New AI Software Vetting Procedure (under construction)

- 1. SCEDIT is working with DoIT to establish a formal procedure for evaluating new software purchases for pedagogical impact (impact on learning objectives, student experience, faculty's effectiveness)
 - a. DoIT already has vetting procedures in place for cyber risk and accessibility
 - b. SCEDIT will advise DoIT in adding a pedagogical assessment procedure to this existing structure. SCEDIT will consult the university community as we do this.
 - c. This is a complex issue because AI impacts pedagogical goals differently in different academic units. We are just at the beginning of this task.
- 2. We discussed problems encountered by IT and CELT with oversight regarding AI programs used on campus:
 - a. Current leased or used programs that introduce AI "suddenly."
 - b. Units purchasing AI without consulting DoIT.
 - c. People are using readily available free or cheap commercial AI programs with university data.
 - d. It's like putting out a lot of fires, and is at least partly responsible for several of our faculty complaints this year (the NotebookLM rollout and GLEAN issues).

SCEDIT Sub-Committees

- Establishment of two subcommittees:
 - 1. Artificial Intelligence (AI) Advisory

- 2. Academic Judiciary Committee (ACJ) Technology Advisory
- SCEDIT members agreed upon both.
- SCEDIT members chose which subcommittee they wanted to join (no one is required to join).
- Charges are still being edited.
- Sub-committees bring motions to be approved by all SCEDIT members, and if approved, move to the senate for consideration.
- Al Advisory
 - ➤ CHAIR: Shyam Sharma

 - > CHARGE: Advise SCEDIT on emerging issues impacting students and faculty

 - > Current Activities:
 - Al Advisory will be focusing on development of a robust resource center for faculty and students.
 - Discussions focus on AI in Education: Challenges and Implications.
 - Sub-committee agreed on the importance of two-way communication, gathering feedback from the community, and providing evidence to inform the Senate's voice.
 - The need for data on faculty's use of AI was highlighted, with the suggestion to pool data from various sources.

- April 2026: All digital content must adhere to WCAG 2.1 AA for public entities with a population over 50,000
- This will impact every area of the university, but Academic Affairs & CELT are focusing on academic/course content.
- CELT offers <u>self-paced trainings</u>, <u>consultations</u>, department visits, and a <u>PDF</u> <u>Remediation</u> pilot
- Top three tips to get started
 - Get PDFs reviewed and remediated
 - Review and update automatic transcripts on course videos
 - Add ALT text or longer descriptions to images
