Greetings from Brenda Anderson, University Senate President

- Welcomed everyone to the University Senate meeting.
- UFS Senate alternates decided that deferred maintenance was the key issue to raise at the UFS Plenary. These concerns were raised through questions from the HSC Sector and Center Sector questions Chancellor King.
- A resolution with specific items of concern arising from the events of last spring was provided, and passed by A&S Senate. It was forwarded to the Executive Committee that has voted to refer items to the appropriate standing committees for review of corresponding policies and providing their initial reports by end of the semester.
- To join the undergraduate student government and the President's office of student affairs for the 7th annual lighting of the Academic Mall, today's meeting will end at 4:45pm.

Report from Interim President McCormick

- Created a Task Force to visit other institutions and bring back ideas/recommendations and estimate the approximate cost of implementing the recommendations.
- Phase one of the Stony Brook Future Scholars Program will be launched end of this week, to work with school districts, particularly disadvantaged school districts, to assist them with preparing and tutoring students, and to assure them if they're admitted to Stony Brook University on the merits, they'll go for free tuition.
- Invited everyone to join the students for the Light the Brook event.

Report from Provost, Carl Lejuez
