# March 4, 2024, 3:30-5:00 PM (Hybrid Meeting – Wang Center Theater & Zoom Meeting)

### **Greetings from Richard Larson, University Senate President**

- Welcomed everyone to the University Senate meeting.
- We are adopting a new voting procedure by providing clickers to senators who have the voting rights including At-Large, departmental, and EC members.
- University President, West and East campus UUP Presidents will be travelling and not be able to present in this meeting.
- Encouraged members to watch the video of Jed Shivers and Carl Lejuez presenting the budget models.

### Budget Update by SVP for Finance and Administration, Jed Shivers

- Presentation shows recent data.
- Tuition generation and the rising tide of CSI expenses were discussed.
- In August, we were in the middle of updating the University's financial information on the budget, financial planning, and analysis website. That information is now updated to include last year's actuals in this year's budget.
- Presented the current and projection views of the academic and research enterprise excluding Hospital, LIV, and FSA.
- Mentioned revenue targets and if we don't meet them then it impacts on our available resources and the amount of funds that SB has for investment.
- Showed current view of the university's financial plan, based on mid-year condition reported by vice presidential units, as there are multiple conversations with VP areas throughout the year to understand where they are in terms of budgets to actuals.
- Mentioned the overall financial position is strong, however, we continue to face challenges on the state purpose side.
- Not all flavors of funds can be used to offset our state deficits.

- The search is open and active to recruit candidates for the next Dean of the College of Arts and Sciences.
- Chief Innovation Officer position hiring is in the final stages.
- Vice President for Research position is in the first round of interviews.
- Remembered Shafiq Fazel who passed away last month. Shafiq served Stony Brook for nearly 10 years, notably serving as Interim Dean of the Libraries for four years. Mentioned his many achievements and accolades, such as SUNYs Chancellor Award for Excellence in Librarianship.
- The passing of Dr. Arthur Grollman who was distinguished Professor of Pharmacological Sciences was announced.
